## AFFIDAVIT (SWORN STATEMENT)

My legal name is **Brett Felber** (“Affiant”) and acknowledge I am:

Being duly sworn, hereby swear under oath that:

1) I, Brett Felber, when I filed the complaint EC-2023-0395 live in Missouri, however I have relocated to the [REDACTED], as I started a business venture there and already have another business venture in the [REDACTED].

2) I, Brett Felber, in addition to owning businesses in Missouri, also own businesses in other states, [REDACTED] etc so forth. I have followed all bylaws and state and federal laws as required by law and am fully compliant with all states rules and regulations for business manners.

3) In addition to having businesses in multiple states, I also establish temporary residency in each state while I am there conducting business or if needed for each business, as the requirements for each business. My tax returns have reflected out of state filings before.

4) Ameren Missouri on May 19, 2023 illegally disconnected utility [REDACTED].

5) Ameren Missouri failed to oblige and honor payment agreement dated May 18, 2023, payable on May 22, 2023. See exhibit.

6) Ameren Missouri failed to oblige payment agreement and to date have deprived the dwelling [REDACTED] from utility services.

- 7) Ameren Missouri in a statement given to the Public Service Commission cannot produce a contradicting statement that is different from the agreed payment agreement emailed to Brett Felber at [REDACTED]
- 8) In a statement collected by the Missouri Public Service Commission, the Public Service Commission acknowledge and even shows where a clear breach in offense, along with failure to restore in which the direct quote, "Ameren did not notify Mr. Felber by personal service first class mail about his default prior to disconnection."
- 9) Despite the Public Service Commission clearly admitting that Ameren failed to follow a Commission rule and regulation, Ameren despite that has failed to restore utility services.
- 10) Ameren Missouri has failed to allow I, Brett Felber, to dispute my balance as there are clear discrepancies and errors on the bill.
- 11) Ameren Missouri was sent a validation and dispute of debt letter on Thursday July 27, 2023. Despite receiving that letter, Ameren has failed to properly put balance in dispute under FDCPA.
- 12) Ameren Missouri has failed under the FDCPA to properly follow Federal laws under guidance .
- 13) Ameren Missouri committed property damage to the premises on June 15, 2023 and to date has failed to rectify the amount of the premises that they have damaged.
- 14) Ameren Missouri, [REDACTED] committed credit card fraud/bank fraud upwards of \$ [REDACTED] off a card/account from the [REDACTED] from one of our addresses.
- 15) [REDACTED] submitted a perjury statement to the Missouri Public Service Commission to not only deceive and continue to keep utility services off at premises, but also to defraud customer and deprive [REDACTED] from any utility services, as a result of their illegal disconnection.
- 16) [REDACTED] submitted a untruthful statement that they weren't party of a lawsuit to the Missouri Public Service Commission and in fact they were party of a lawsuit [REDACTED], to deprive premises [REDACTED].
- 17) [REDACTED] in a filing submitted as part of a lawsuit has used methods of slander, defamation and libel in trying to accuse Brett Felber of being prejudice.
- 18) I, Brett Felber am not prejudice in any matter, in fact from my wife's side of the family I have a diverse background of interracial relatives in which I get along with all ethnic groups of people I am friends with many with different cultures and backgrounds.
- 19) I, Brett Felber, have a letter from the FTC showing that the balance Ameren claims is owed is fraudulent, due to Ameren failing to follow state laws and federal laws. ( See Exhibit).
- 20) I, Brett Felber have verifiable call logs from my carrier T-Mobile in which show the dates of May 1-18th of May Ameren Missouri failed to reach out to me about disconnection of services, etc. ( See attached exhibit.)

- 21) To date Ameren continue to deprive premises from any restoration of utility services, despite being presented with clear evidence, documents and exhibits.
- 22) To date Ameren has failed to supply any sufficient documentation showing that they legally disconnected services. All they have provided to the commission is templates, not actual verification or email documents or exhibits backing their claim.
- 23) I, Brett Felber admit that the address in this is a mailing agent address in the area of [REDACTED], while I purchase a house and my mailing agent is allowed to receive all mail under USPS form 1583 and followed all rules and regulations.
- 24) [REDACTED] made a perjury and slander statement that I and Lisa Lambert or implied that we weren't married.
- 25) I submitted a statement that Lisa Lambert and I were having marital issues, however never stated that we weren't married.
- 26) Ameren Missouri has a history against me in not following state statutes, rules, regulations, tariffs etc. In fact in 2022 under another complaint filed against them Ameren Missouri failed to follow disconnection protocols not once, but twice, however were ordered to restore electric services.
- 27) I, Brett Felber, believe that Ameren is committing extortion against me, in trying to make me pay a bill I don't owe and can prove that there are inaccurate amounts on my billing statements.
- 28) I, Brett Felber believe that until they receive a payment amount that is under dispute or they've failed to allow me to dispute they aren't going to restore service, regardless .
- 29) Ameren Missouri has used illegal tactics such as telephone spoofing and impersonation of a Government Entity known as Boone County Government. ( See attached exhibit)

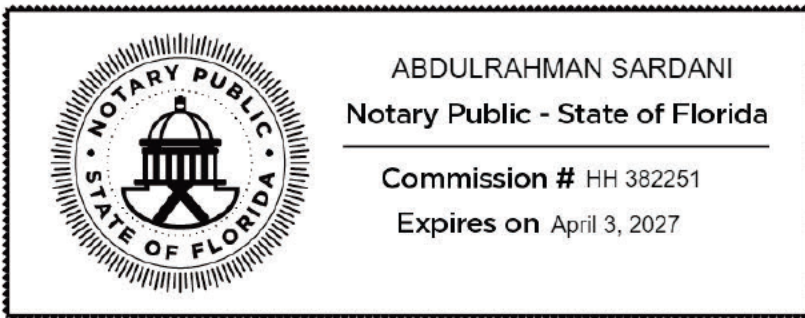
