## MOTION TO SUSPEND PROCEDURAL SCHEDULE

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE) and for its Motion to Suspend Procedural Schedule, states as follows:

- 1. On December 5, 2007, the Missouri Public Service Commission (Commission) issued an Order Adopting Procedural Schedule.
- 2. During the course of this proceeding, the parties have continued to discuss the Industrial Demand Response (IDR) tariff and have reached a verbal agreement on the design of the IDR tariff. The agreed upon resolution will require the current tariff on file to be withdrawn and a new tariff to be filed. However, the Procedural Schedule requires AmerenUE to file Direct Testimony today, December 21, 2007.
- 3. AmerenUE asks that the Commission issue an order suspending the procedural schedule at this time. The Company hopes to file the revised tariff and the associated Stipulation and Agreement soon, however, given holiday schedules, AmerenUE asks that it be given until January 11, 2008.
