MOTION TO WITHDRAW

COMES NOW the undersigned counsel and respectfully submits her Motion To Withdraw in the above referenced matter. In support of the Motion, the undersigned states as follows:

- 1. The undersigned was retained by Deborah S. Arnott, Vice President/Director of Compliance of IG2, Inc. to represent IG2, Inc., on or about September 1, 2001.
- 2. On or about October 4, 2001, IG2, Inc. filed an application with the Commission for approval of an interconnection agreement with Southwestern Bell Telephone Company under the provisions of the Federal Telecommunications Act of 1996. On or about November 1, 2001, staff recommendation was received recommending the PSC grant IG2, Inc. approval of the interconnection agreement. Said staff recommendation and accompanying documents were faxed to the attention of Ms. Arnott at IG2, Inc. on or about November 1, 2001.
- 3. On or about November 14, 2001, the PSC issued its order approving the interconnection agreement and asking that a copy of the interconnection agreement with the pages sequentially numbered and a notice so advising the PSC be filed by November 26, 2001.

On November 15, 2001, said order was faxed to Ms. Arnott at IG2, Inc.

4. Since that time, although there has been numerous correspondence and telephone

calls attempted to both IG2, Inc. and to Deborah Arnott, no response of any kind has been

received by the undersigned.

5. The undersigned has learned that the fax and telephone numbers to IG2, Inc. have

been disconnected. In addition, an overnight package sent on April 3, 2002, to IG2, Inc. was

returned with a notation that the receiver had moved and therefore the package was

nondeliverable.

6. The undersigned contacted the Delaware Secretary of State's office to request

current information and was informed the corporation is no longer in good standing due to

failure to file regulation documents.

7. Although numerous steps have been taken to locate and contact IG2, Inc. and/or

Deborah Arnott, we have been unsuccessful.

8. Due to the foregoing reasons, the undersigned believes she can no longer

reasonably nor adequately represent this client.

WHEREFORE, the undersigned respectfully requests the Commission issue its order

allowing the undersigned to withdraw as counsel to IG2, Inc. and for any other relief deemed just

and proper in the premises.
