## MOTION FOR LEAVE TO FILE ANNUAL REPORT OUT OF TIME

Comes now Fidelity Cablevision, Inc.'s ("Fidelity" or "Company") and for its Motion for Leave to File Annual Report Out-of-Time states to the Missouri Public Service Commission ("Commission") as follows:
