REQUEST OF PAE TEC COMMUNICATIONS, INC. TO EXTEND THE FILING DATE FOR ITS ANNUAL REPORT

COMES NOW Pae Tec Communications, Inc. ("Pae Tec"), by and through its attorneys and, pursuant to 4 CSR 240-10.080(8), respectfully requests the Missouri Public Service Commission ("Commission") to extend the filing date for its Annual Report. In support of its request, Pae Tec states as follows:

1. Pae Tec is a certificated interexchange carrier in Missouri with its principal place of business located at 290 Wood Cliff Drive, Fairport, New York 14450.

2. As a telecommunications utility subject to the jurisdiction of the Commission, Pae Tec is required to file annual reports with the Commission each year by April 15, on a form provided by the Commission or on a computer generated replica which is acceptable to the Commission (4 CSR 240-10.080(1)&(4)).
