MOTION TO OPEN CASE AND CANCEL CERTIFICATE OF SERVICE AUTHORITY AND ACCOMPANYING TARIFF

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and moves that the Missouri Public Service Commission (the Commission) cancel the certificate of service authority and accompanying tariff of Nations Bell, Inc. d/b/a MTS/Communicall (MTS or the Company). In support of its Motion, Staff states as follows:

- 1. On January 23, 1996, the Commission granted Nations Bell, Inc. d/b/a Nations Tel and Nations Bell, Inc. d/b/a MTS/Communicall certificates (plural) of service authority to provide intrastate interexchange telecommunications services in the State of Missouri, and approved the Company's tariffs, which were both labeled as P.S.C. Mo. No. 1¹.
- 2. On April 22, 2002 the Commission issued its *Order Recognizing Name Change*², acknowledging the name change of Nations Bell, Inc. to Nations Broadband, Inc. and approving an adoption notice reflecting the name change in the Company's tariff (singular) for Nations Bell, Inc. d/b/a Nations Tel.
- 3. On June 26, 2007, Staff received a letter from the attorney for Nations Broadband, Inc. indicating that the Company had ceased its Missouri operations and requesting the

cancellation of its certificate (singular) of service authority. The request made no explicit mention of either fictitious name. See Exhibit A.

- 4. Accordingly, on June 27, 2007, Staff filed a *Motion to Cancel Certificate of Service Authority and Accompanying Tariff*, recommending the Commission cancel the certificate (singular) of service authority of Nations Broadband, Inc. In Staff's motion, Staff makes mention of the Commission authorized use of the fictitious name "Nations Tel," but does not mention the authorized use of the fictitious name "MTS/Communicall."
- 5. On September 27, 2007 in Case No. XD-2007-0493, the Commission issued its *Order Canceling Certificate and Accompanying Tariff*, canceling the certificate (singular) of service authority issued to Nations Broadband, Inc. (originally Nations Bell, Inc. d/b/a Nations Tel) in Case No. TA-96-157, and canceling the Company's tariff (singular) P.S.C. Mo. No. 1.
- 6. In the attached correspondence, labeled Exhibit B, the attorney for Nations Broadband, Inc. indicates that it was the Company's intention to also have the certificate of service authority of Nations Broadband, Inc. d/b/a MTS/Communicall cancelled per his 2007 letter (Exhibit A). See Exhibit B.
- 7. The Commission has the authority to cancel the certificate of service authority of a telecommunications corporation pursuant to Section 392.410.5 RSMo (2000)³, which provides that "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."
- 8. However, the Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. 1989).
 - 9. MTS is current in the payment of it Commission assessments.

10. The Company was current in the filing of its Annual Report when, in 2007, the Company requested cancellation of its certificate.

WHEREFORE, Staff recommends the Commission cancel the certificate of service authority granted to Nations Bell, Inc. d/b/a MTS/Communicall to provide intrastate interexchange telecommunications services and the accompanying tariff P.S.C. Mo. No. 1.
