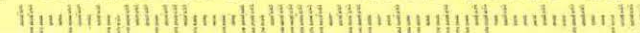

On March 13, 2020, the Manager of the Manufactured Housing and Modular Units Program filed a motion asking the Commission to open a working case to assist the Manager to determine the appropriate fees for the services provided by the Manufactured Housing and Modular Units Program. The Manager also asks the Commission to schedule a workshop to facilitate discussion. The Commission will grant that motion.


