ORDER OF RULEMAKING

By the authority vested in the Public Service Commission under section 700.040, RSMo 2016, the commission rescinds a rule as follows:

4 CSR 240-121.040 Inspection of Dealer Books, Records, Inventory and Premises is rescinded.

A notice of proposed rulemaking containing the proposed rule rescission was published in the *Missouri Register* on May 15, 2018 (43 MoReg 1012). No changes have been made in the proposed rescission so it is not reprinted here. This proposed rescission becomes effective thirty (30) days after publication in the Code of State Regulations.
