# Important notice

Kansas City Power & Light Company has filed revised electric service tariff sheets with the Missouri Public Service Commission that would increase the company's Missouri jurisdictional annual gross revenues by \$92 million or approximately 14%. For the typical residential customer, the increase would be approximately \$12.69 per month.
