MOTION TO ESTABLISH RESPONSE DATE

COME NOW UtiliCorp United Inc. ("UtiliCorp") and St. Joseph Light & Power Company ("SJLP"), by and through its counsel, and for their Motion to Establish Response Date respectfully state as follows to the Missouri Public Service Commission ("Commission"):

- 1. On or about November 19, 1999, the Office of the Public Counsel ("OPC") filed in the caption docket its Motion to Require Market Power Study. On November 22, 1999, the OPC filed its response to the Motion to Establish Procedural Schedule previously filed by UtiliCorp and SJLP. Also on November 22, 1999, the Commission issued its Order Setting an Early Prehearing Conference in this matter, said prehearing conference to be held on December 6, 1999. By that same order, the Commission indicated that responses to the UtiliCorp/SJLP Motion to Establish Procedural Schedule filed would be due on November 25, 1999. UtiliCorp and SJLP anticipate that the Commission Staff and possibly other Intervenors will file a response to their Motion to Establish Procedural Schedule and will possibly file other motions.
- 2. UtiliCorp and SJLP desire the opportunity to respond to all of said pleadings and would like to do so in a single document prior to the December 6, 1999 prehearing conference.

 Accordingly, UtiliCorp and SJLP desire that the Commission issue its order granting UtiliCorp and



SJLP up to and including Friday, December 3, 1999, to file their response to the pleadings of the other parties. UtiliCorp and SJLP will electronically transmit or fax their response to all parties on that date.

WHEREFORE, UtiliCorp and SJLP respectfully move the Commission to grant the relief requested in paragraph 2 supra.
