AMERENUE'S MOTION TO RESCHEDULE AGENDA DISCUSSION


COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE) and hereby states as follows:

1. On January 23, 2007, the Missouri Public Service Commission issued its Notice of Discussion at Agenda in which it invited representatives of parties to this case to its January 30 agenda meeting to answer questions from the Commissioners about the Stipulation Agreement that has been filed in this case.
2. Many of the parties to this case are also parties to AmerenUE's pending electric and gas rate cases, Case Nos. ER-2007-0002 and GR-2007-0003. Pursuant to the procedural schedule approved by the Commission in those cases the rebuttal testimony of all parties on revenue requirement issues is due January 31, 2007. In addition, rebuttal testimony on class cost of service and rate design issues is due February 5, 2007.
3. As a result of the demands associated with finalizing rebuttal testimony in those cases it will be difficult for key personnel from AmerenUE and potentially the other parties to attend the January 30, 2007 agenda meeting.

WHEREFORE, AmerenUE requests the agenda discussion be re-scheduled to a date after February 5, 2007.
