MOTION FOR LEAVE TO FILE 1999 ANNUAL REPORT

Matrix Telecom, Inc., by and through its undersigned counsel, moves the Missouri Public Service Commission to grant it leave to file its 1999 Annual Report after the April 15, 2000 deadline. In support of this motion, Matrix Telecom, Inc. states as follows:

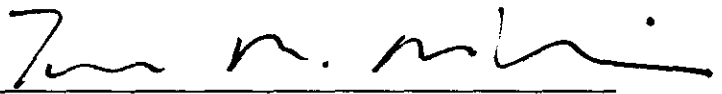
1. Matrix Telecom, Inc. ("Matrix") signed its 1999 Annual Report on April 14, 2000 and mailed the same to the Missouri Public Service Commission (the "Commission") for filing. The Commission did not receive Matrix's 1999 Annual Report until April 17, 2000, which was after the April 15, 2000 filing deadline. Shortly thereafter, the Commission returned the 1999 Annual Report to Matrix and stated that it was being returned for two reasons. First, the Commission indicated that Matrix had failed to meet the requirement for proper disclosure of financial information in its Annual Report,¹ and, second, that Matrix needed to have a Missouri attorney submit an original, plus 14 copies of a pleading requesting an extension of time to file its Annual Report.

2. Due to matters associated with Matrix Acquisition Holdings Corp.'s acquisition of Matrix in 1999 and the corresponding difficulty getting timely financial information for reporting purposes, Matrix failed to file its 1999 Annual Report by the April 15, 2000 deadline. Matrix now respectfully requests leave to file the attached 1999 Annual Report.

¹ The attached 1999 Annual Report now complies with this requirement.

WHEREFORE, Matrix Telecom, Inc. respectfully requests that the Missouri Public Service Commission grant it leave to file the attached 1999 Annual Report.

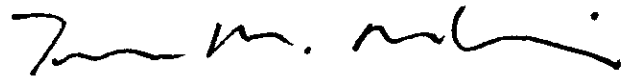

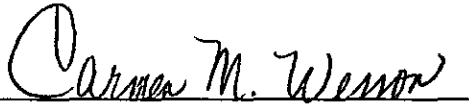

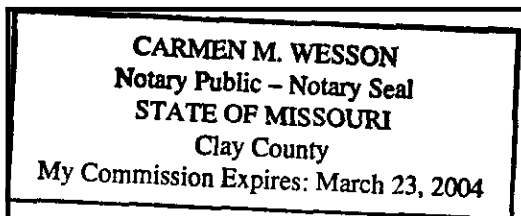
