ORDER GRANTING LEAVE TIME TO FILE ANNUAL REPORT OUT OF TIME AND CLOSING CASE

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On June 29, 2000, Business Discount Plan, Inc. (BDP) requested the Commission accept its 1999 annual report, which was filed along with its application for leave to file its annual report out of time. BDP stated that, at the conclusion of the calendar year 1999, it made available to Gene Querry & Associates its financial records to enable BDP to file annual reports in all states, including the state of Missouri. BDP stated that because of "press of business" and the volume and complexity of the financial information, Gene Querry & Associates was unable to timely provide BDP with the necessary information to incorporate into its annual report to be filed with the Missouri Public Service Commission.

BDP stated that initially it filed its 1999 annual report on May 4, 2000, but that the annual report was returned as late filed in violation of rule 4 CSR 240-10.080(1). BDP requested that the Commission permit BDP to late file its annual report as of June 29, 2000.

The Commission finds that good cause exists to permit the filing of BDP's annual report out of time and the Commission will grant BDP's request.

IT IS THEREFORE ORDERED:

- 1. That Business Discount Plan, Inc.'s Application to File Late Annual Report, filed on June 29, 2000, is granted, and the annual report filed on June 29, 2000, shall be considered timely filed.
 - 2. That this order shall become effective on October 5, 2000.
 - 3. That this case may be closed on October 6, 2000.
