- JUDGE THOMPSON: Good afternoon. My name is
- 3 Kevin Thompson. I'm the Regulatory Law Judge assigned to
- 4 preside over this matter, which is in the matter of the
- 5 Spectra Communications Group, LLC, doing business as
- 6 CenturyTel, proposed revision to its PSC Mo. No. 3 long
- 7 distance message telecommunications service tariff to
- 8 introduce the promotional Macon expanded calling plan, Case
- 9 No. IT-2004-0141, Tariff No. JI-2004-0148.
- 10 We are here for a prehearing conference, and
- 11 why don't we begin with oral entries of appearance with
- 12 CenturyTel.
- MR. DORITY: Thank you, Judge. Appearing on
- 14 behalf of the applicant Spectra Communications Group, LLC,
- 15 doing business as CenturyTel, Larry Dority and James
- 16 Fischer, Fischer & Dority, PC. Our address is 101 Madison,
- 17 Suite 400, Jefferson City, Missouri 65101.
- JUDGE THOMPSON: Thank you, Mr. Dority.
- 19 Staff?
- 20 MR. BATES: Thank you, Judge. My name is
- 21 Bruce H. Bates. I'm appearing on behalf of William Haas for
- 22 the Missouri Public Service Commission Staff. My address is
- 23 Post Office Box 360, Jefferson City, Missouri 65102.
- 24 JUDGE THOMPSON: Thank you. Then we have some
- 25 intervenors. Let's see. The Missouri Independent Telephone

- 1 Group.
- MS. CHASE: Thank you, your Honor. Lisa
- 3 Chase, Bryan Lade and Craig Johnson appearing on behalf of
- 4 the Missouri Independent Telephone Group and Chariton
- 5 Telecom Corporation, at Andereck, Evans, Milne, Peace &
- 6 Johnson, LLC, 700 East Capitol, Jefferson City, Missouri
- 7 65102.
- 8 JUDGE THOMPSON: Thank you. And the other
- 9 intervenor, AT&T Communications of the Southwest?
- 10 MR. COMLEY: Your Honor, let the record
- 11 reflect the entry of appearance of Mark W. Comley, Newman,
- 12 Comley & Ruth, P.C., 601 Monroe, Jefferson City, Missouri,
- 13 on behalf of AT&T Communications of the Southwest, Inc.
- JUDGE THOMPSON: Thank you, Mr. Comley.
- 15 Let the record reflect that the Public Counsel
- 16 is not currently present. Is there anyone else here,
- 17 late-breaking intervenors? Okay. Very well.
- This tariff was suspended, I think last week,
- 19 and the Commission directed me to set this for a very prompt
- 20 prehearing conference. The Commission is interested in
- 21 resolving this matter as quickly as possible. And,
- 22 therefore, we have not set the filing of a proposed
- 23 procedural schedule off to a week from today. Instead,
- 24 we're going to develop it on the record while we're all here
- 25 today, which will be a change from our more typical

- 1 practice.
- Now, Mr. Bates, I think I saw you on the
- 3 street during the lunch break and you told me you actually
- 4 had a motion prepared. I wonder if you'd like to reveal
- 5 that to us at this time.
- 6 MR. BATES: Yes, your Honor. I did prepare a
- 7 shell motion, and Mr. Dority asked to look at it and
- 8 supplied some suggested dates, which are acceptable to
- 9 Staff, as far as I know.
- 10 JUDGE THOMPSON: But you have not had a chance
- 11 to share this generally?
- 12 MR. BATES: I have not. I just received it a
- 13 short time ago, and I only have the one copy here. I'd be
- 14 happy to read the dates out.
- MR. FISCHER: We have copies.
- MR. DORITY: We have copies.
- 17 JUDGE THOMPSON: Why don't you read them out
- 18 so that I know what they are? We can work from there.
- 19 MR. BATES: According to this, the filing of
- 20 direct testimony would be on November 13th, filing of
- 21 rebuttal testimony on December 4th, filing of the list of
- 22 issues on December 11th, filing of surrebuttal testimony on
- 23 December 18th, filing of statements of positions, the order
- 24 of opening statements and the order of cross-examination on
- 25 December 30th, the evidentiary hearing on January 5th

- 1 through 7th of 2004. An expedited transcript would be filed
- 2 on January 9th. The Initial Briefs would be due on
- 3 January 16th, Reply Briefs on January 23rd, and a proposed
- 4 request that the Commission issue its Order on or before
- 5 February 12th, which would be 120 days beyond the
- 6 October 15th tariff effective date.
- 7 JUDGE THOMPSON: Okay. Have you ascertained
- 8 that those hearing dates are, in fact, open?
- 9 MR. BATES: They are open to counsel for
- 10 Staff.
- 11 JUDGE THOMPSON: I mean on the Commission
- 12 calendar are they open?
- 13 MR. BATES: I did not have time to check the
- 14 Commission calendars.
- JUDGE THOMPSON: I think that's going to be
- 16 the controlling choke point here, because I think the
- 17 Commission calendar is more full than I've ever seen it in
- 18 the time I've been here. Every utility has come in with a
- 19 rate case simultaneously. We've got to send thank you notes
- 20 for that.
- 21 MR. BATES: I'd be happy to go upstairs and
- 22 check if you'd like.
- JUDGE THOMPSON: I think we'll have to do
- 24 that, because that's going to drive everything else really.
- MR. BATES: And are there any other dates that

- 1 I should be checking on besides that or simply the first
- 2 three days in a row that are available?
- 3 MR. JOHNSON: Judge?
- 4 JUDGE THOMPSON: Sir?
- 5 MR. JOHNSON: Pardon me for interrupting, your
- 6 Honor, but I was wondering whether three days was calculated
- 7 or whether it was just guesstimated, and I was wondering if
- 8 there might be a likelihood of trying this case in less than
- 9 three days, in which case you might be able to find two
- 10 consecutive day spots on the calendar before he goes up and
- 11 checks it.
- MR. DORITY: If I may respond?
- JUDGE THOMPSON: Yes, sir.
- 14 MR. DORITY: It was primarily a guesstimate,
- 15 Craig, knowing that the Commission likes to err on the side
- 16 of having more time reserved than less. We may well be able
- 17 to try this in one or two days, but three was -- we picked,
- 18 and I did not have a chance to check the hearing calendar.
- 19 I know from a previous case in which I was involved that
- 20 there may be a conflict with the water case, I'm not sure,
- 21 during that first week, but --
- JUDGE THOMPSON: I think that there might be.
- 23 The water case starts December 15th, goes for a week and a
- 24 half and breaks and comes back.
- MR. DORITY: It was somewhat fluid, and that's

- 1 why I went ahead and did that. In terms of the actual
- 2 schedule itself, Judge, we simply looked at a -- knowing the
- 3 Commission's desire to resolve this matter as quickly as
- 4 possible, we simply looked 120 days out from the tariff's
- 5 suspension and simply worked backwards trying to build into
- 6 the proposed schedule the normal time frames that the
- 7 Commission has utilized in the past. That brought us to
- 8 that hearing date.
- 9 JUDGE THOMPSON: You did a fine job putting
- 10 this together, but I think we're certainly going to have to
- 11 take a look at the hearing calendar and see what's
- 12 available, and perhaps we might have to make some
- 13 adjustments to it based on that.
- 14 Bruce, did you want to go up and check the
- 15 hearing calendar? We'll go ahead and recess until you come
- 16 back.
- 17 (Discussion off the record.)
- JUDGE THOMPSON: We've examined the hearing
- 19 calendar maintained by the adjudication division and
- 20 determined that the earliest available and reasonably
- 21 appropriate hearing dates will be Tuesday, January 20th,
- 22 2004 through Friday, January 23rd, 2004. And those four
- 23 dates then will be reserved just in case unexpectedly the
- 24 case will, in fact, require three days or close to three
- 25 days. Any days we don't need can be relinquished when it's

- 1 seen that they will not be necessary.
- 2 So are those dates acceptable to all of the
- 3 parties?
- 4 MR. DORITY: Yes, your Honor.
- 5 MR. BATES: Yes, sir.
- MS. CHASE: Yes, your Honor.
- 7 JUDGE THOMPSON: Then I will leave you to fill
- 8 in the rest of the dates for the other procedural matters
- 9 according to the normal intervals. Given that we've got the
- 10 hearing dates, you know how long is available for filing of
- 11 testimony. Afterwards I guess we'll do two rounds of
- 12 simultaneous Briefs. Is that acceptable?
- Originally you wanted a decision by
- 14 February 12th. You'll probably have to kick that out
- 15 another couple weeks in view of the hearing being later than
- 16 had originally been anticipated, but certainly by the end of
- 17 February. How's that? That work?
- 18 MR. BATES: Your Honor, do I understand that
- 19 when we agree upon the dates today, you would like a motion
- 20 for establishment of procedural schedule filed in the normal
- 21 manner this afternoon?
- JUDGE THOMPSON: That would be great, this
- 23 afternoon or tomorrow.
- MR. DORITY: Judge, in terms of the decision
- 25 rendered by the end of February, how much time should we

3	JUDGE THOMPSON: A couple weeks. We'll try t
4	get it done as quickly as we can.
5	Anything else at this point? Hearing nothing
6	else, the prehearing conference will be adjourned. Thank
7	you all very much for appearing today on such short notice
