Notice of Link Up Termination

COMES NOW Chariton Valley Telecom Corporation (“CV Telecom”) and, for its Notice of Link Up Termination , and states the following:

1. CV Telecom hereby notifies the Commission that, by Report and Order and Further Notice of Proposed Rulemaking released February 6, 2012, “In the Matter of Lifeline and Link Up Reform and Modernization”, WC Docket No. 11-42, et al., at paragraphs 4 and 240-254, the FCC has eliminated the Link Up Program except for recipients on Tribal Lands, effective in March of 2012.

2. CV Telecom’s Application herein was filed prior to the FCC’s February 6, 2012 Order. The original Application at paragraphs 17 and 20 stated CV Telecom’s commitment to provide Link Up discounts pursuant to federal and state rules as part of its eligible telecommunications carrier commitments.

3. Pursuant to the FCC Order, Link Up is no longer available. CV Telecom hereby puts the Commission on notice that, should its Application herein is granted, Link Up discounts will not be provided. CV Telecom is not requesting future participation in any aspect of the Link Up program. CV Telecom requests that those portions of paragraphs

17 and 20 of the original Application, which at the time suggested to the contrary, now be disregarded.

WHEREFORE, on the bases of the foregoing CV Telecom respectfully requests that the commission designate it as a telecommunications carrier eligible under the provisions of 47 CFR 54.201(d) to receive federal universal service support, to certify such designation to the FCC, and for such other orders as are deemed necessary or convenient in this matter.


