## MOTION TO STRIKE TESTIMONY

Kansas City Power & Light Company ("KCPL" or "Company") submits its Motion to Strike the late-filed Surrebuttal Testimony of W. Bill Dias. In support of its motion, KCPL states as follows.

1. On October 12, 2006, Mr. Dias and/or Dias Capital Growth Corporation, Inc. submitted 12 pages of surrebuttal testimony in the above-referenced case.

Pursuant to the procedural schedule ordered by the Commission on March 29,
2006, all surrebuttal testimony was due to be filed October 6, 2006.

3. Mr. Dias' surrebuttal testimony was not accompanied by a motion for leave to file out of time.

4. The testimony submitted by Mr. Dias is not in compliance with Commission rule 4 CSR 240-2.130(6) in that it is not accompanied by an affidavit providing the witness's oath. In addition, testimony is not on line-numbered pages nor is it double spaced.

5. The surrebuttal testimony does not address the rebuttal testimony of any witness. The testimony does address Anita Randolph's surrebuttal testimony. However, Commission rule 4 CSR 240-2.130(7)(D) requires that surrebuttal testimony be limited to material which is responsive to matters raised in another party's rebuttal testimony. 6. Mr. Dias' testimony should be stricken as it is outside the procedural schedule issued in this case. Moreover, as outlined above the testimony does not comply with the Commission's rules.
