**MOTION FOR CLARIFICATION AND
REQUEST FOR EXPEDITED TREATMENT**

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE or the Company) and, pursuant to 4 CSR 240-2.160, submits this Motion for Clarification and Request for Expedited Treatment and states as follows:

1. On June 8, 2009, at 4:38 p.m., Public Counsel (OPC) filed its *Motion to Suspend* (Motion) asking that the tariff sheets for Rider L be suspended so that it could further consider AmerenUE's filing.

2. On June 9, 2009, at approximately 11:00 a.m., the Commission issued an Order Directing Response, directing AmerenUE to file its response to OPC's Motion, stating: "In particular, the Commission directs AmerenUE to file a copy of the cost-effectiveness analysis that is referenced in paragraph 4 of Public Counsel's motion." The ordering language was less specific, stating that AmerenUE was to "... file its response to Public Counsel's Motion ...". AmerenUE's filing was due no later than 8:00 a.m. on June 10, 2009. This deadline was less than 24 hours after the Order was issued, and less than 48 hours after OPC's Motion was filed.

3. Under normal Commission procedure, AmerenUE would have 10 days to respond to OPC's Motion. 4 CSR 240-2.080 (15).

4. AmerenUE does not believe it was the Commission's intent to allow it less than 48 hours to submit its response to OPC's Motion. Instead, AmerenUE believes the

Commission was seeking specific information prior to an Agenda Session, which was held at 8:30 a.m. on June 10, 2009. AmerenUE requests the Commission to clarify that the Company is still allowed to file an additional response to OPC's Motion as long as it is filed by June 18, 2009.

5. Additionally, AmerenUE requests expedited treatment. Pursuant to 4 CSR 240-2.080(16), the Company requests a Commission order by June 15, 2009, so that the Company has time to draft its response. There will be no negative effect on the party's customers or the general public in granting this expedited treatment request. This pleading was filed as soon as the Company was aware that there might be some confusion regarding the issue.

WHEREFORE, AmerenUE respectfully requests the Commission issue an order, no later than June 15, 2009, clarifying that AmerenUE is allowed until June 18, 2009 to respond to OPC's Motion.
