## MOTION FOR EXPEDITED TREATMENT

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "Company") and, pursuant to 4 CSR 240-2.160, submits its Motion for Expedited Treatment and states as follows:

- 1. The parties in this case filed a Stipulation on July 5, 2012, titled Unanimous Stipulation and Agreement Resolving Ameren Missouri's MEEIA Filing ("Stipulation").
- 2. The Commission issued an order on August 1, 2012, approving the Stipulation. The Stipulation provided for approval of the Company's proposed Technical Resource Manual ("TRM"). The TRM sets forth measures and the level of energy savings associated with each measure.
- 3. Concurrent with this pleading, the parties are filing an *Agreement to Include Additional Measures in Ameren Missouri's Technical Resource Manual* ("Agreement"). The Agreement contains five attachments. Attachment A contains a brief explanation of each additional measure and where information on that measure can be found in the revised TRM. Attachment B is the revised TRM. Attachment C is a redlined version of the revised TRM, so that all changes from the Commission-approved TRM can be identified. Attachment D is the revised list of residential incentive ranges. New measure incentive ranges are highlighted in yellow. Changes to the previously

approved ranges are highlighted in blue. Attachment E is the revised list of business incentive ranges. New measure incentive ranges are highlighted in yellow.

4. Ameren Missouri requests this Agreement be approved so that it is effective on February 13, 2013. Ameren Missouri has filed this request for expedited treatment as soon as possible after deciding the changes were necessary and after receiving consent from all other parties in this matter. There will be no negative effect on the party's customers or the general public in granting this expedited treatment request.

WHEREFORE, Ameren Missouri respectfully requests the Commission issue an order approving the Agreement and the revised TRM (Attachment B), the new incentive ranges (Attachments D and E) and to order that these documents replace the TRM and incentive ranges which were approved earlier in this case and issue the order so that it is effective no later than February 13, 2013.
