## MOTION FOR EXPEDITED TREATMENT AND APPROVAL OF TARIFF SHEETS FILED IN COMPLIANCE WITH COMMISSION ORDER ON LESS THAN THIRTY DAYS NOTICE

COMES NOW Union Electric Company d/b/a Ameren Missouri (Ameren Missouri or Company) and for its Motion, states as follows:

- 1. The Missouri Public Service Commission (Commission) issued its *Order Approving Infrastructure System Replacement Surcharge, but Rejecting Tariff (Order)* on October 3, 2013.
- 2. The *Order* requires Ameren Missouri to file a new tariff to recover the revenue authorized in the *Order*. Concurrent with this filing, Ameren Missouri has filed its compliance tariff.
- 3. Ameren Missouri asks the Commission to approve the compliance tariff so that it is effective on October 18, 2013. The compliance tariff bears an issue date of October 3, 2013, and an effective date of November 2, 2013. Section 393.140(11) allows that, if the Company shows good cause, the Commission may allow the tariff to take effect without requiring thirty days notice. October 18, 2013, is the first date that Ameren Missouri's billing system can implement the new rate.
- 4. Good cause exists because the Commission has already found that Ameren Missouri is entitled to an additional \$1,266,546 because the Company currently has a revenue

deficiency of that amount. This *Motion* has been filed as early as possible after the Commission order was issued and there will be no negative effect on customers or any party.

**WHEREFORE**, Ameren Missouri respectfully requests the Commission issue an order approving the compliance Infrastructure System Replacement Surcharge tariff so that it is effective on October 18, 2013.
