**MOTION TO EXTEND THE TIME  
TO FILE RESPONSE TO MOTION TO SUSPEND AND INVESTIGATE TARIFF  
AND FOR OTHER RELIEF**

Comes now Hypercube Telecom, LLC, and for its above entitled motion states the following to the Commission:

1. On September 29, 2011, AT&T Missouri (AT&T) filed a Motion to Suspend and Investigate Tariff (the Motion) respecting the tariffs submitted by Hypercube in conjunction with its application in this matter (the Tariffs).

2. Because the Tariffs had an effective date of October 10, 2011, and because a state holiday would compress the Commission's time to act on the both the Motion and Staff's recommendation on the Tariffs which is due October 5, 2011, the Commission directed Staff and other parties to file a response to the Motion by October 5, 2011.

3. Hypercube has by letter to the Commission Secretary---filed and delivered today--  
- agreed to a further extension of the effective date of the Tariffs to October 24, 2011. This

additional time will allow Hypercube, Staff, AT&T and other parties to further review and evaluate the Tariffs, and perhaps resolve any objections.

4. Hypercube submits that an extension of time for the parties to file a response to the Motion is warranted given that the effective date of the Tariffs has been extended. Likewise, the date on which Staff's recommendation is due should also be reset.

WHEREFORE, Hypercube respectfully requests that the Commission extend the time for: 1) responses to the Motion; and 2) Staff's recommendation, for an additional twelve days, up to and including October 17, 2011.
