MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY

COMES NOW Staff of the Missouri Public Service Commission (Staff) and moves the Missouri Public Service Commission (Commission) cancel Jeffrey DeBlase's (Mr. DeBlase) certificate of service authority to provide private pay telephone service via customer-owned coin telephone equipment. For said Motion, Staff respectfully states the following:

1. On April 23, 2003, the Commission issued an order granting a certificate of service authority to Mr. DeBlase to provide private pay telephone service via customer-owned coin telephone equipment, in Case No. PA-2003-0364.
2. On February 13, 2008, the Commission received Mr. DeBlase's Statement Of Revenue FY 2009 Mo. PSC Assessment, reporting zero revenue and indicating Mr. DeBlase no longer wishes to retain his operating certificate. The assessment is attached as Appendix A.
3. Mr. DeBlase owes no past assessments to the Commission.
4. Mr. DeBlase does not currently provide any regulated intrastate services to customers in Missouri.
5. Because Mr. DeBlase has requested cancellation of his certificate and is not providing pay telephone service in Missouri, Staff recommends the Commission issue an order canceling said certificate.
6. The Commission has the authority to cancel a telecommunications certificate

pursuant to Section 392.410.5 RSMo (Supp. 2006), which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

7. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. 1989).

WHEREFORE, the Staff respectfully recommends the Commission cancel the certificate of service authority of Jeffrey DeBlase, to provide private pay telephone service in the State of Missouri via customer owned coin telephone equipment.
