<u>MOTION TO CANCEL</u> <u>CERTIFICATE OF SERVICE AUTHORITY TO PROVIDE</u> INTRASTATE INTEREXCHANGE TELECOMMUNICATIONS SERVICES

BellSouth Long Distance, Inc. d/b/a AT&T Long Distance Service ("BSLD") respectfully requests¹ cancellation of its certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri, and states:

1. BSLD, a Delaware corporation with its principal office located at 675 West Peachtree Street NW, Suite 32O46, Atlanta, Georgia 30308, received a certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri from the Commission in an "Order Approving Interexchange Certificate of Service Authority and Order Approving Tariff," issued June 6, 1997, in Case No. TA-97-476.²

2. BSLD has no customers in Missouri and no longer actively offers or provides intrastate interexchange services in Missouri (and has not for years). Canceling the certificate would help conserve BSLD and Commission resources by eliminating the time and expense of making the annual filings necessary to maintain certification and engage in the telecommunications business in the State.

² BSLD subsequently received a certificate of service authority to provide basic local telecommunications services in the state of Missouri from the Commission in an "Order Approving Merger, Granting Certificate of Service Authority, and Approving Tariff" issued July 1, 2004, in Case No. LM-2004-0552. At BSLD's request, the Commission canceled the basic local certification in an "Order Canceling Certificate and Accompanying Tariff" issued September 6, 2011, in Case No. CD-2012-0055.

3. The Commission has the authority to cancel a certificate of service authority pursuant to Section 392.410.5 RSMo.: "[a]ny certificate of service authority may be altered or modified by the [C]ommission after notice and hearing, upon its own motion or upon application of the person or company affected." The Commission need not hold a hearing if, following proper notice and opportunity to intervene, no party requests a hearing.³

WHEREFORE, BSLD respectfully requests the Commission to grant this Motion and cancel BSLD's certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri.
