MOTION TO EXTEND PROCEDURAL SCHEDULE

COMES NOW the Office of the Public Counsel (Public Counsel) and respectfully moves the Missouri Public Service Commission to make and enter its order extending the procedural schedule in this case for two weeks. Public Counsel, the Staff and Southwestern Bell Telephone Company (SWBT) have been discussing how to obtain all data requested from SWBT and CLECs via the Staff's data requests and the potential for identifying uncontested issues or grounds for the settlement of issues.

To that end, Public Counsel proposes to extend the procedural schedule to see if those discussions can produce any results and allow the parties to incorporate the data requested in the outstanding data requests into the rebuttal and surrebuttal testimony.

Public Counsel proposes to extend the time to file rebuttal testimony from Thursday, August 9, 2001 to Thursday, August 23, 2001; to extend the deadline for filing of surrebuttal testimony from Tuesday, September 11, 2001 to Tuesday, September 25, 2001; and reschedule the hearing dates from September 24-28, 2001 to October 9-12, 2001. The dates for the filing of issues and position statements would be adjusted to the new schedule. (Issues and Witness list filed September 28th and position statements October 2nd) The prehearing scheduled for August 24th can remain unchanged.

Public Counsel has contacted counsel of record concerning this proposed extension and the following parties have advised that they do not object to this requested modification of the procedural schedule: McCleod Communications, IP, Nuvox, Inc., AT&T Communications of the Southwest, Inc., Allegience, WorldCom, OX, Mpower, Sprint, Southwestern Bell Telephone and the PSC Staff. Counsel for SWBT indicated that if the hearing dates were postponed past October 12, 2001 he would have significant scheduling problems and could not agree to hearing dates beyond that date in October. No other counsel voiced any objection to the extension of the schedule.

WHEREFORE, Public Counsel requests that the Public Service Commission modify the procedural schedule as suggested in this motion.
