## **MOTION FOR PROTECTIVE ORDER**

COMES NOW Kansas City Power & Light Company ("KCPL"), pursuant to 4 CSR 240-2.085, and hereby requests the Missouri Public Service Commission ("Commission") to issue a protective order in the above-captioned case. In support thereof, KCPL states as follows:

1. Simultaneously with the filing of this motion, KCPL has submitted an Application and supporting testimony that contains certain proprietary and highly confidential information. In accordance with 4 CSR 240-2.085, KCPL hereby requests that the Commission issue a protective order in this proceeding in order to protect its proprietary and highly confidential information from public disclosure. Disclosure of such information would harm the financial and competitive interests of the Company. None of the information for which a claim of confidentiality is made can be found in any format in any other public document. KCPL requests the Commission to issue its standard protective order in the same form as has been customary in previous cases.

2. KCPL notes that the Commission has issued this standard protective order in numerous other dockets where it has recognized a genuine need to protect confidential information from disclosure. The issuance of protective orders in prior proceedings has helped to minimize disputes, and has provided a sound method for parties to submit confidential information.

WHEREFORE, for the reasons set forth herein, KCPL respectfully requests the Commission to issue a protective order in this proceeding, in the same form as has been customary in previous cases.
