**MOTION TO CANCEL EVIDENTIARY HEARING**

COMES NOW Applicant Missouri RSA No. 7 Limited Partnership, d/b/a Mid-Missouri Cellular ("MMC"), by and through counsel, and for its Motion to Cancel Evidentiary Hearing, states as follows:

1. Pursuant to the Commission's September 30, 2005 Order, the evidentiary hearing in this matter scheduled for November 28 through November 30, 2005.
2. There is currently pending an offer to purchase all of the assets of MMC. In the event such a transaction is consummated, MMC would not be qualified to be granted ETC status. Until there is more certainty as to whether MMC's assets will be sold the evidentiary hearing should be canceled. If the assets are sold MMC will voluntarily dismiss its Application. If the assets are not sold MMC will request a hearing at a later date.

WHEREFORE, MMC respectfully request the Commission enter an Order canceling the evidentiary hearing in this case.
