1. Ameren Missouri is a Missouri corporation, in good standing in all respects, with its principal office and place of business located at 1901 Chouteau Avenue, St. Louis, Missouri 63103. The Company is engaged in providing electric and gas utility services in portions of Missouri as a public utility under the jurisdiction of the Missouri Public Service Commission (Commission). Ameren Missouri, like KCP&L Greater Missouri Operations Company, is subject to Missouri's Renewable Energy Standard ("RES").
