**MOTION TO OPEN CASE AND CANCEL CERTIFICATE OF SERVICE**  
**AUTHORITY AND ACCOMPANYING TARIFF**

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its Motion to Open Case and Cancel Certificate of Service Authority and Accompanying Tariff, respectfully states as follows:

1. On April 30, 1997, the Missouri Public Service Commission (Commission) granted a certificate of service authority to provide intrastate interexchange telecommunications services to Global Telemedia International, Inc. (GTII) in Case No. TA-97-391. Telecommunications companies are required to file a Missouri-specific annual report pursuant to Section 392.210.1 and 392.390 (1) RSMo 2000. A certificated company is also required to keep the Commission informed of its current address and telephone number.

2. GTII did not file an annual report for 1999 as required by the Commission's rules and statutes. Additionally, GTII's 2000 annual report form was returned by the post office as undeliverable. According to the Missouri Secretary of State's website, GTII was administratively dissolved on September 28, 1998 for failure to file an annual report.

3. GTII has not filed a formal request to cancel its certificate. However, the Staff believes that GTII has violated the terms of its certificate by its failure to keep the Commission

informed of its current address and telephone number and its failure to file annual reports. The Commission has the authority to cancel a telecommunications corporation certificate pursuant to Section 392.410.5 RSMo 2000, which provides:

Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.

However, the Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494 (Mo. App. 1989).

WHEREFORE, the Staff recommends the Commission cancel the certificate of service authority to provide interexchange telecommunications services and the accompanying tariff of Global Telemedia International, Inc.
