MOTION TO CONFIRM TERMINATION OF STEAM
UTILITY SERVICE AND TO CLOSE DOCKET

Comes now Kansas City Power & Light Company (KCPL), and moves the Commission to confirm that KCPL's public utility steam service obligation in downtown Kansas City, Missouri, expires as of December 31, 1990, and accordingly to close this case. In support of this motion, KCPL states as follows:

1. In its October 7, 1987, Report and Order in this case, the Commission authorized KCPL to terminate steam utility service as of December 31, 1990, and to undertake certain other obligations.

2. Contemporaneously with this motion, KCPL has filed a Report with the Commission, demonstrating that it has fully discharged its obligations under said Report and Order. The Report is incorporated herein by reference.

3. The entry of the Order requested herein is purely ministerial, and is necessary to permit definitive planning to be undertaken immediately by KCPL's utility steam heat customers for facilities necessary to be installed prior to the cessation of steam service, now merely 24 months away.

WHEREFORE, KCPL prays for the Order of the Commission finding:


