MOTION TO CORRECT ORDER

COMES NOW Laclede Gas Company (hereinafter "Laclede" or "Company") and in support of its Motion to Correct Order, states as follows:

1. On October 31, 2008, Laclede filed a proposed tariff sheet setting new Purchased Gas Adjustment ("PGA") rates. The tariff sheet bore an effective date of Monday, November 17, 2008, in conformance with the ten business day notice requirement in Section E.2 of the Company's PGA clause.

2. On Friday, November 14, 2008, the Commission issued its Order Approving Interim Rates ("Order"), in which it approved Laclede's proposed tariff sheet. The Effective Date of the Order was November 16, 2008. Laclede was accordingly prepared to implement its new PGA rates effective on Monday, November 17.

3. However, in the last recital paragraph of the Order, just before the ORDERED paragraph, the Commission indicated an effective date of November 14, 2008, two days before the effective date of the Order. And the approved tariff was returned to Laclede stamped effective Sunday, November 16, 2008 with a line struck through the Company's proposed November 17 effective date.

4. Laclede was not prepared to make the new rates effective on either Friday, November 14 or Sunday, November 16, but instead had its billing system prepared for a Monday, November 17 effective date. Laclede believes the Commission intended the

Company to make the new rates effective on the 17th, consistent with the date indicated in the heading of the Staff Memorandum, and not on the 14th or 16th.

5. The Company therefore requests that the Commission correct both the Order and the approved tariff *nunc pro tunc* to reflect an effective date for the tariff of November 17, 2008. These corrections will clarify the effective date of the tariff, avoid the administrative burden of issuing corrected bills, and carry out the intent of the Commission.

WHEREFORE, for the foregoing reasons, Laclede respectfully requests that the Commission correct the Order *nunc pro tunc* to reflect an effective date for the tariff of November 17, 2008.
