**AT&T MISSOURI'S MOTION
TO ESTABLISH PROCEDURAL SCHEDULE**

AT&T Missouri,¹ pursuant to the Missouri Public Service Commission's ("Commission's") January 31, 2006 Order Denying Motion to Dismiss, Extending Temporary Waiver and Scheduling Prehearing Conference, and respectfully proposes the following procedural schedule, which would potentially allow the resolution of all issues in the case by the end of May:

The issues that will be presented here are complex and technical. Granting the requested time to prepare prefiled testimony will allow the parties to present to the Commission the


information it will need to decide all issues in this case. Counsel for AT&T Missouri has conferred with counsel for Staff, MITG, STCG, CenturyTel and Sprint and has incorporated all requested revisions into this proposed schedule.

In order to accommodate this procedural schedule, AT&T Missouri also respectfully requests the Commission to extend the current temporary waiver from March 31, 2006 until May 31, 2006.


