**MOTION TO EXTEND TIME FOR FILING  
PROPOSED PROCEDURAL SCHEDULE**

COME NOW Respondents Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company (collectively, "Respondents"), by and through their legal counsel, and for their Motion to Extend Time for Filing Proposed Procedural Schedule respectfully state as follows:

1. In its *Order Extending Time To File Proposed Procedural Schedule* issued in this matter on August 25, 2009, the Commission ordered the parties to file a proposed procedural schedule no later than September 1, 2009. As discussed in the prehearing conference and previous pleadings filed herein, the parties have engaged in settlement discussions and Respondents report that those settlement discussions recently concluded without an agreed upon proposed resolution.

2. As a result, Respondents respectfully suggest that an additional extension by approximately one week of the filing date for a proposed procedural schedule<sup>1</sup> would be helpful.

3. Respondents are authorized to state that neither the Staff of the Commission nor the Office of the Public Counsel object to the specific relief requested herein.

WHEREFORE, Respondents respectfully request that the Commission grant their Motion and extend the deadline for filing a proposed procedural schedule up to and including September 9, 2009.
