MOTION FOR AUTHORITY TO FILE AMENDED APPLICATION

Under authority of, and in accordance with, 4 CSR 240-2.080, Union Electric Company d/b/a Ameren Missouri and Boone Electric Cooperative jointly seek an order authorizing them to file an amended application in the above-captioned case. The original application, filed October 8, 2015, contained two errors: one a typographical error in the address of the property that is the subject of the application and the other concerning the identity of the property's owner. The amended application would correct both those errors. The amended application the joint applicants propose to file is attached to this motion as Attachment 1.

Staff, the Office of the Public Counsel, and the Regulatory Law Judge assigned to the case have each been advised of the errors and of the joint applicants' intent to file this motion, and the joint applicants believe no party to this case will be prejudiced or adversely affected if this motion is granted.

WHEREFORE, for the reasons stated above and to ensure all information relevant to the Commission's consideration of this application is accurate, Ameren Missouri and BEC ask the Commission to grant this motion and order the joint applicants to file their amended application.

**AMENDED JOINT APPLICATION FOR AUTHORITY TO
TRANSFER CUSTOMERS BETWEEN ELECTRIC SUPPLIERS**

Under authority of, and in accordance with, Sections 393.106 and 394.315, RSMo, 4 CSR 240-2.060, and 4 CSR 240-3.140, Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri” or “the Company”) and Boone Electric Cooperative (“BEC” or “the Cooperative”) jointly seek an order transferring to Ameren Missouri the exclusive right to provide retail electric service to property at 16100 South Hagans Road, Ashland, Missouri, which is owned by the Bade Raymond-Anna Trust, Ms. Laverne Garrett trustee (“Garrett Property”).

1. Ameren Missouri, a Missouri corporation, provides electric and gas utility services to customers in its Missouri service areas. The Company’s principal office is at 1901 Chouteau Avenue, St. Louis, Missouri 63103. Ameren Missouri is an “electrical corporation,” a “gas corporation,” and a “public utility,” as each of those terms is defined in Section 386.020, RSMo, and therefore is subject to the general regulatory jurisdiction and supervision of the Commission, as provided by law.

2. BEC, a Missouri corporation organized under Chapter 394 of the Revised Statutes of Missouri, is a rural electric cooperative providing electric energy and related services to cooperative members in Boone, Audrain, Callaway, Howard, Monroe, and Randolph Counties.

The Cooperative's principal office is at 1413 Rangeline, Columbia, Missouri, 65205. The Cooperative is neither an "electrical corporation" nor a "public utility," as each of those terms is defined in Section 386.020, RSMo; therefore, the Commission has only limited regulatory jurisdiction over BEC, as provided by law.

4. Ameren Missouri previously filed with the Commission (i) a certified copy of the Company's Articles of Incorporation (Case No. EA-87-105); (ii) a copy of its fictitious name registrations (Case Nos. GO-98-486 and EN-2011-0069); and (iii) a copy of its Certificate of Corporate Good Standing (Case No. EA-2013-0502). Those documents are incorporated by reference and made a part of this application for all purposes, as authorized by 4 CSR 240-2.060(1)(G).

5. BEC previously filed with the Commission a copy of its Certificate of Corporate Good Standing (Case No. EO-2015-0012). That document is incorporated by reference and made a part of this application for all purposes, as authorized by 4 CSR 240-2.060(1)(G). BEC does not have a fictitious name registration on file with the Missouri Secretary of State.

6. Ameren Missouri has no overdue Commission annual reports or assessment fees, and has no pending or final unsatisfied judgments or decisions against it from any state or federal agency or court that have occurred within the three years immediately preceding the filing of this application and involve customer service or rates, except for the appeal of Ameren Missouri's 2014 electric rate case (File No. ER-2014-0258), which is pending before the Missouri Court of Appeals, Western District (WD78688).

7. BEC has no overdue Commission reports or assessment fees, and has no pending or final unsatisfied judgments or decisions against it from any state or federal agency or court that have occurred within the three years immediately preceding the filing of this application and involve customer service or rates.

8. In accordance with a letter agreement dated June 11, 2015, BEC agrees to transfer to Ameren Missouri responsibility for providing retail electric service to the Garrett Property, and further agrees to sell the Company thirteen poles, twelve spans of conductor, and related appurtenances the Cooperative uses to provide service to that location.¹ A more specific description of the Garrett Property is as follows: a 155 acre tract located in the east half of the northwest quarter section and the west half of the northeast quarter section of Section 12, Township 24, Range 46 at the south end of South Hagans Road in Boone County, Missouri. A copy of the letter agreement and a diagram showing the Garrett Property are attached to this

application as Exhibit A and Exhibit B, respectively, and are incorporated by reference and made a part of this application for all purposes. Although the letter agreement states Ms. Garrett is fully aware of the proposed transfer and gives her consent, 4 CSR 240-3.140(H) requires a verified statement from the customer consenting to the transfer. A copy of an affidavit giving consent for the proposed transfer is attached as Exhibit C and is incorporated by reference.

9. In their territorial agreement, which the Commission approved in a Report and Order dated March 16, 1999, in Case No. EO-99-267, Ameren Missouri and BEC designated areas in Boone County where each company has the exclusive right to provide retail electric service, subject to certain exceptions. One such exception is that as of the effective date of the territorial agreement each signatory retained the right to continue to provide service to any “Existing Structure”² regardless of where such structure was located. Although the Garrett Property is located within Ameren Missouri’s exclusive service area as defined by the territorial agreement, on the effective date of that agreement the Garrett Property was served by BEC and the Cooperative exercised its right to continue to provide service. However, both BEC and Ms. Garrett, as trustee, now consent to transfer to Ameren Missouri the exclusive right to provide retail electric service to the Garrett Property.

10. The Company is able to provide safe and reliable electric service to the Garrett Property, and approving the proposed change of electric suppliers is in the public interest for at least three reasons. First, the Garrett Property is within an area Ameren Missouri is obligated to serve under the terms of its territorial agreement with BEC. Second, the proposed transfer will allow the Cooperative to remove approximately 0.75 miles of distribution line it cannot use to serve other customers, and will relieve BEC of future maintenance costs associated with the line.

² Article 1.6 of the territorial agreement defines “Existing Structure” to include “any structure that receives electric energy from either party prior to or on the effective date of this Agreement.”

Finally, removal of the line also will benefit two other nearby customers who have been unable to use and develop their properties because the Cooperative's line and associated easements have impeded such use and development.

11. The issues raised by this application do not create or involve a "contested case" as defined by Section 536.010(4), RSMo; therefore, the sixty-day notice provisions of 4 CSR 240-4.020(2) do not apply.

WHEREFORE, having shown the proposed transfer to Ameren Missouri is in the public interest and the affected customer consents, the applicants request the Commission issue an order approving a change in electrical suppliers for the Garrett Property, and granting such other relief as the Commission deems appropriate under the circumstances.

This letter is intended to memorialize the agreement of Ameren Missouri, Ms. Laverne Garrett and Boone Electric Cooperative ("BEC"), (collectively referred to herein as the "Parties") regarding electric service to property owned by Ms. Garrett located at 16001 S. Hagans Rd., Ashland Missouri ("Premises"). Currently, BEC is providing electric service to the Premises.

BEC and Ameren Missouri hereby agree to transfer the responsibility and right to provide electric service to the Premises to Ameren Missouri at a date to be determined. Ms. Laverne Garrett, being fully aware of the intended transfer of electric service providers from BEC to Ameren does hereby consent and agree to such transfer. Furthermore, Ms. Garrett hereby agrees to grant, at no cost to BEC or Ameren Missouri, easement(s) to accommodate placement of pole anchors as necessary.

The parties attest and acknowledge that this transfer will only affect electric service to the Premises owned by Ms. Laverne Garrett. This transfer will require the sale, via a mutually agreed to bill of sale between Ameren Missouri and BEC, regarding approximately 13 poles and 12 spans of conductor and other appurtenances as set forth on the attached map.

Please sign all three included copies and return to Boone Electric Cooperative, Attn: Kirk M Pickett, 1413 Rangeline St., Columbia, MO 65201. Once all copies are completed an original signed document will be sent to you for your records.

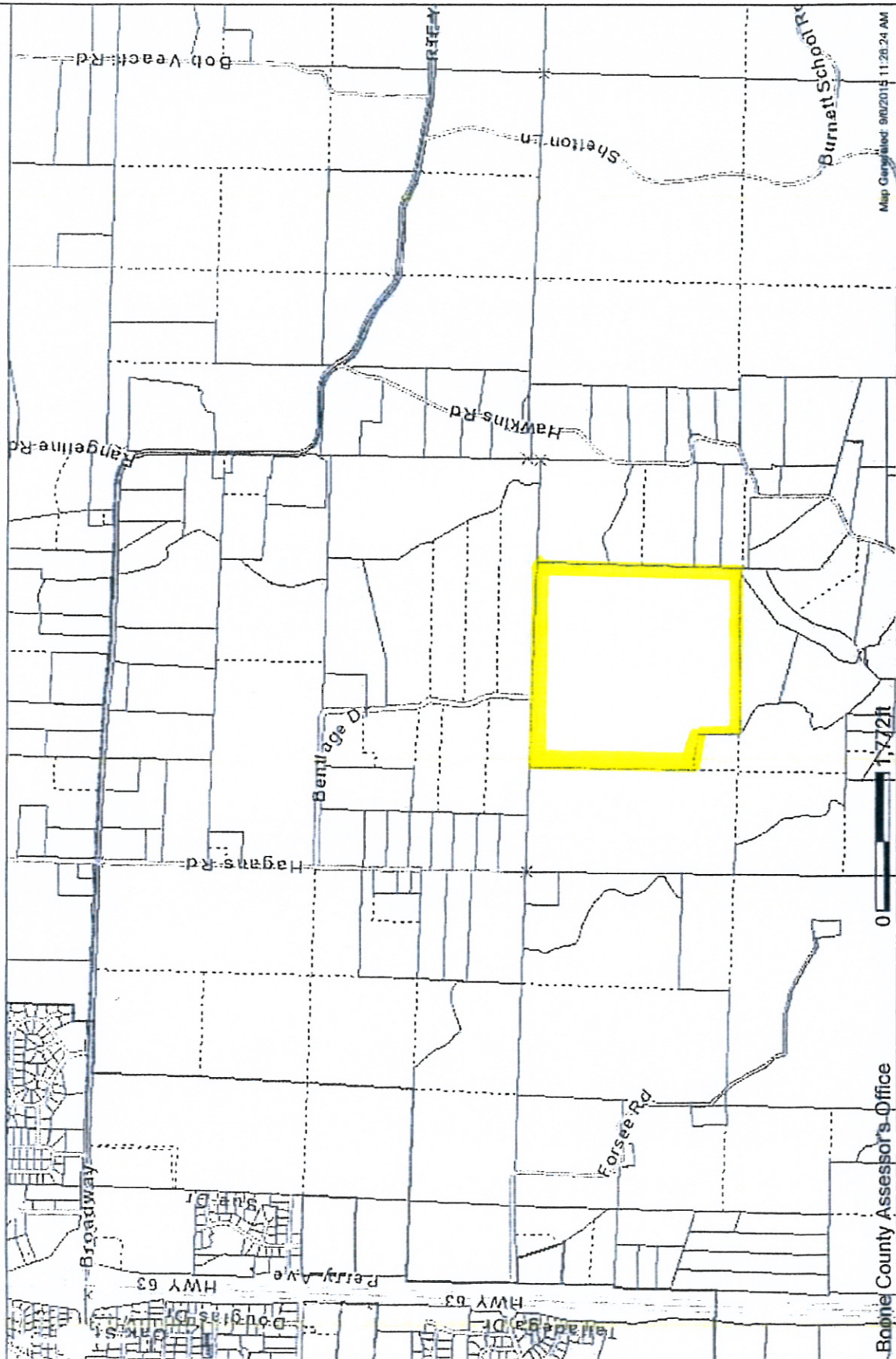


