1. The exact legal name of the applicant is Laclede Gas Company ("Laclede"), and its principal place of business is located at 720 Olive Street, St. Louis, Missouri 63101.

2. The names, titles and addresses of the persons to whom correspondence, communications, orders and decisions in this matter are to be sent are as follows:

3. Laclede is a natural gas distribution company, subject to the Commission's jurisdiction, which operates as a retail distributor and transporter of natural gas in the City of St. Louis and the Missouri Counties of St. Louis, St. Charles, Jefferson, Ste. Genevieve, St. Francois, Madison, Iron, Butler and Franklin. More than one-half million residential, commercial and industrial gas users in Missouri rely on Laclede for reasonably priced, dependable supplies of natural gas.

4. On November 7, 1995, Union Electric Company ("UE") filed an application with the Commission requesting an Order authorizing certain merger transactions involving UE, the transfer of certain assets, real estate, leased property, easements and contractual agreements, and other transactions involving the proposed merger by and between UE and Central Illinois Public Service Company ("CIPSCO"). By Order and Notice dated November 15, 1995, the Commission directed any party wishing to intervene in this case to file an application requesting intervention no later than the close of business December 15, 1995.

5. A large majority of Laclede's customers, and Laclede itself, are also customers of UE. As both a customer and competitor of UE, Laclede has a substantial and direct interest in the scope, nature and terms of the proposed transactions, including the effect of the transactions on UE's rates, terms and conditions of providing electric service.

6. In light of the foregoing, it is clear that Laclede's interest is different than that of the general public. Laclede's interest, therefore, cannot be adequately represented by any other party to this proceeding.
