**AMENDMENT TO APPLICATION FOR DESIGNATION AS AN
ELIGIBLE TELECOMMUNICATIONS CARRIER ON A WIRELESS BASIS**

COMES NOW Assurance Home Phone Services, Inc. d/b/a Surety Wireless (“Assurance Home Phone” or the “Company”) and, pursuant to 4 CSR 240-2.080(20) files this Amendment to its Application for Designation as an Eligible Telecommunications Carrier on a Wireless Basis (“Application”). In support of its Amendment, Assurance Home Phone states as follows:

1. On March 23, 2011, Assurance Home Phone filed its Application for Designation as an Eligible Telecommunications Carrier on a Wireless Basis. Included in that Application was the statement in Paragraph 14(d) that, “Under the FCC Rules, an ETC applicant must demonstrate that it will satisfy applicable consumer protection and service quality standards¹; Assurance Home Phone will satisfy all such standards. As part of its certification requirements for providing local exchange services, Assurance Home Phone must abide by the service quality and consumer protection rules. ... Assurance Home Phone in general commits to satisfying all such applicable state and federal requirements related to consumer protection and service quality standards.”

2. Assurance Home Phone respectfully requests that Paragraph 14(d) of its Application be amended to add the following statement to Paragraph 13(f): “Assurance Home Phone will satisfy consumer privacy protection standards as provided in 47 CFR 64 Subpart U and service quality standards as applicable.”²”

WHEREFORE, Assurance Home Phone respectfully requests that Paragraph 14(d) of its Application for Designation as an Eligible Telecommunications Carrier on a Wireless Basis be amended to include the statement that Assurance Home Phone will satisfy consumer privacy protection standards as provided in 47 CFR 64 Subpart U and service quality standards as applicable, in compliance with 4 CSR 240-3.570(2)(A)8.
