**NOTICE OF TARIFF SHEET COMPLIANCE FILING  
AND REQUEST FOR AUGUST 1, 2007 EFFECTIVE DATE**

COMES NOW Laclede Gas Company ("Laclede" or "Company") and, pursuant to the Commission's July 19, 2007 Order Approving Unanimous Stipulation and Agreement and Authorizing Tariff Filing, submits this Notice of Tariff Sheet Compliance Filing and Request for August 1, 2007 Effective Date. In support thereof, Laclede states as follows:

1. On December 1, 2006, Laclede submitted to the Commission proposed tariff sheets intended to implement a general rate increase for natural gas service provided to customers in the Missouri service area of the Company.

2. On July 9, 2007, the parties to this case filed a Unanimous Stipulation and Agreement resolving all of the issues in this proceeding. Attachment 2 to The Unanimous Stipulation and Agreement also included specimen tariff sheets that were subsequently amended in part by a filing made by Laclede on July 12, 2007.

3. On July 19, 2007, the Commission issued its Order Approving Unanimous Stipulation and Agreement and Authorizing Tariff Filing in which it approved the Stipulation and Agreement and authorized Laclede to file compliance tariff sheets consistent therewith. Laclede has filed such compliance tariff sheets on this date ("Compliance Tariff Sheets").

4. In its Order Approving Unanimous Stipulation and Agreement, the Commission stated that because one of the provisions of the Unanimous Stipulation and Agreement contemplated an August 1, 2007, effective date for the implementing tariffs, there was good cause for allowing compliance tariff sheets to become effective by August 1, 2007, assuming such tariff sheets were in compliance with the Unanimous Stipulation and Agreement. Pending confirmation by the Commission Staff, Laclede believes that the Compliance Tariff Sheets filed today are in compliance with the Unanimous Stipulation and Agreement and therefore requests that the Commission approve such Compliance Tariff Sheets effective for service on and after August 1, 2007.

WHEREFORE, for the foregoing reasons, Laclede Gas Company respectfully requests that the Commission take note of this compliance tariff filing and issue its Order approving the Compliance Tariff Sheets for service rendered on and after August 1, 2007.
