LIBERTY UTILITIES' NOTICE OF VOLUNTARY DISMISSAL

COMES NOW Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities ("Liberty Utilities" or "Company") and, pursuant to Section 4 CSR 240-2.116 of the Commission's Rules, submits its Notice of Voluntary Dismissal of the Application filed in the above captioned case on September 30, 2018. In support thereof, Liberty Utilities states as follows:

On September 30, 2018, Liberty Utilities filed an Application seeking Commission approval of a replacement plan for the PVC pipe that remains in the Company's distribution system. Since the filing of the Application, Staff and the OPC have filed recommendations and pleadings in which they have raised questions about the need to seek pre-approval of the Company's plan to replace PVC pipe from its system prior to a future request by the Company to seek recovery of such replacement costs in its ISRS mechanism. In light of Staff and OPC's positions, and the Company's recent understanding that the Commission previously determined that all of the expenditures made by Ameren Missouri to completely eliminate PVC pipe from its distribution system were properly included in and recovered through that utility's ISRS mechanism, *see e.g.*

Re: Union Electric Company d/b/a Ameren Missouri, File No. GO-2014-0015; Tariff No. YG-2014-0022, the Company is voluntarily dismissing this action.

WHEREFORE, the Company respectfully requests that the Commission take notice of this voluntary dismissal and cancel the April 3, 2019 procedural conference currently scheduled in this case.
