COMES NOW, the Office of the Public Counsel ("Public Counsel") and for its recommendation in the above-referenced proceeding states as follows:

- On or about February 17, 2000 Southern Union Company ("SUC") filed its 1. Application for authority to acquire the common stock of and to merge with Valley Resources, Inc. ("VRI"), and, in connection therewith, certain other related transactions.
- 2. The Commission on or about February 23, 2000 issued its Order establishing time for filing recommendations directing that recommendations regarding approval or rejection of the application filed by SUC be filed by Public Counsel no later than June 15, 2000.
- 3. On or about May 22, 2000 SUC filed its Amended Application in this proceeding adding additional customer service criteria to the commitment set forth in paragraph 19 of its initial Application and reaffirming all the other commmitments contained in its initial application.
- 4. Public Counsel does not oppose the granting of SUC's application provided that the Commission adopt all of the conditions set forth in the initial Application and in SUC's Amended Application filed on May 22, 2000.

WHEREFORE, Public Counsel requests the Commission approve Southern Union Company's Application for authority to acquire the common stock of and to merge with Valley Resources, Inc. in this matter with all the conditions contained in its Application and Amended Application.
