## NOTICE OF COST ALLOCATION MANUAL SUBMISSION

**COMES NOW** Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "Company") and gives notice that it has submitted its Cost Allocation Manual ("CAM") applicable to its electric and gas operations for calendar year 2020, as required by the Commission's Affiliate Transactions Rules and in accordance with the variance granted it respecting the due date for the CAM in File No. EE-2019-0241. With respect to this Notice, Ameren Missouri states as follows:

1. Originally pending in this docket was a CAM for calendar year 2017 agreed upon between Ameren Missouri and the Staff of the Commission. Because this docket had not yet been resolved when the 2018 CAM was due, on May 15, 2019 Ameren Missouri filed a Notice in this docket indicating that it would instead ask for approval of its CAM applicable to its 2018 operations. Ameren Missouri made that request in its direct testimony filed in this docket on June 14, 2019.

2. Thereafter, this docket was stayed after request by the parties by the Commission's August 23, 2019 *Order Staying Proceedings*. Consequently, the Commission has not yet taken up approval of a CAM.

3. A CAM submittal is required each year and Ameren Missouri's CAM submittal for 2020 is due May 15, 2021. That CAM submittal is in all material respects the same as the 2017, 2018, and 2019 CAMs previously submitted in this docket except for updated information reflecting calendar year 2020 and a deletion of references to benchmarking no longer available that had been referenced in prior testimony from Company witness Jeff Dodd. 4. Please note that because the 2020 CAM supersedes the 2019 CAM, Ameren Missouri will at a later time as appropriate in this docket, request that the Commission approve the 2020 CAM.
