**NOTICE OF CHANGE APPLICATION**

2. The Company seeks a franchise to provide video service in the following additional communities and political subdivisions within the state of Missouri, each of which assess the following video service provider fees:



(1) Fidelity agrees to comply with all applicable federal and state laws and regulations;


(2) A list of additional political subdivisions and communities to be served by the Company is accurately set forth in the application to which this affidavit is attached;


