**MOTION TO MODIFY CUSTOMER EDUCATION REPORT
DATE FOR 314 NPA AND 816 NPA RELIEF PLANS**

COMES NOW Sprint Missouri, Inc. d/b/a Sprint ("Sprint") serving as company chair of the customer education subcommittee plan for the 816 NPA Relief Plans, and requests an extension/modification to the Commission-ordered report date for the 816 NPA Relief customer education plan. In support of this request, Sprint states as follows:

1. On February 15, 2001, the Commission approved the NPA relief implementation plan in this Case, which originally called for permissive dialing to begin on October 20, 2001. As part of its February 15, 2001 order, the Commission also ordered the customer education subcommittee to file a summary of the customer education plan with the Commission prior to its implementation to be filed no later than July 9, 2001.

2. On April 17, 2001, the Commission issued its Order Extending the 314 NPA and 816 NPA Relief Plan Implementation Dates ("4/27/01 Order") in this case. In its 4/27/01 Order, the Commission extended the implementation dates for the 314 NPA (557 overlay) as follows:

- Permissive dialing date: January 1, 2002
- Mandatory dialing date: May 5, 2002

The Commission also extended the implementation dates for the 816 NPA (975 overlay) as follows:

- Permissive dialing date: May 5, 2002

- Mandatory dialing date: September 8, 2002

3. In light of the Commission's 4/17/01 Order extending the implementation date, the Commission's February 15, 2001 deadline of July 9, 2001 for the education sub-committee to file a summary of the 816 NPA Relief customer education plan is no longer a relevant date. Due to the April 17, 2001 ordered implementation delay, the education subcommittee has not finalized the development of the 816 NPA Relief customer education plan. Sprint feels it prudent to finalize such a plan closer to the actual implementation date, rather than over six months in advance of the permissive dialing period.

4. For the reasons described above, Sprint as company chair of the customer education subcommittee plan for the 816 NPA Relief Plans, proposes that the Commission modify its deadline for the customer education subcommittee to file its customer education plan from July 9, 2001 to not less than 60 days prior to the implementation of the 557 and 975 overlay NPAs.

WHEREFORE, for the reasons described above, the parties request that the Commission modify the deadline for the customer education plan to be filed as set forth in paragraph 4 above.


