**MOTION FOR EXPEDITED TREATMENT**

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE or the Company)  
and for its Motion for Expedited Treatment, states as follows:

1. Concurrent with this filing, AmerenUE is filing tariff sheets to amend its electric tariff PSC. Mo. No. 5, Sheets No. 196 and 197, titled Variances and Promotional Practices.

2. These sheets implement a program AmerenUE calls Project Power On. The tariff is designed to provide financial assistance to residential customers who choose to participate in the Company's Project Power On initiative by converting their existing overhead service wire installation to an underground service cable installation.

3. AmerenUE originally filed this tariff on October 2, 2007 (JE-2008-0210) with an effective date of November 2, 2007. The Company has withdrawn that tariff and made modifications at the request of the Commission Staff and the Office of Public Counsel.

4. AmerenUE has made plans to roll out this program on the original effective date and asks the Commission to grant expedited treatment and to approve the tariff no later than the date it would have initially been effective, November 2, 2007.

5. This pleading has been filed as soon as was practical after the decision to make the requested changes was made.

6. Attorneys for the Commission Staff and for the Office of Public Counsel have indicated that they do not object to this motion or to the tariff.

WHEREFORE, for the reasons stated herein, AmerenUE respectfully requests that the Commission approve the tariff sheets filed herewith to take effect on November 2, 2007.
