**MOTION FOR EXPEDITED TREATMENT**

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE or the Company) and, pursuant to 4 CSR 240-2.160, submits its Motion for Expedited Treatment and states as follows:

1. Concurrent with this filing, AmerenUE submitted a tariff titled "Personal Energy Manager Rebate Pilot." This tariff was filed with a 30 day effective date, meaning it would become effective August 22, 2009, unless the Missouri Public Service Commission (Commission) took action to prevent that occurrence.

2. Pursuant to 4 CSR 240-2.080(16), AmerenUE requests the Commission issue an order approving the tariff so that it may be effective no later than August 6, 2009.

3. This pilot is a residential price response program and the best time to gain experience with this pilot is during the summer months, when the Company is most likely to experience peak usage. The pilot expires on October 31, 2009, so moving the effective date to August 6, 2009, will provide the Company an additional two weeks of experience with the pilot.

4. AmerenUE has filed this request as soon as it could. The Company has been working with Commission Staff and the Office of the Public Counsel in order to

facilitate as much agreement on the tariff language as possible. There will be no negative effect on the party's customers or the general public in granting this expedited treatment request.

WHEREFORE, AmerenUE respectfully requests the Commission issue an order approving the Personal Energy Manager Rebate Pilot so that it is effective no later than August 6, 2009.
