**MOTION FOR EXTENSION OF TIME TO REVIEW TRANSCRIPT OF  
IN-CAMERA PROCEEDINGS**

COMES NOW Respondent New Florence Telephone Company ("New Florence") and for its request for an extension of time to comply with the Commission's Order Directing New Florence Telephone Company to Prepare a Public Version of the Transcript of In-Camera Proceedings dated July 13, 2006, (the "Order"), states the following:

1. The Commission's Order has directed New Florence to file by no later than July 17, 2006, a public version of Volume 3 of the transcript of proceedings of July 6, 2006, in the captioned case. New Florence has no objection to reviewing the transcript and declassifying and making public as much information as possible that is contained therein, however, lead counsel for New Florence currently is out of the office and will not return until the 17th and, additionally, New Florence witness Robert Williams will be out of state for several days.

2. In order to give the company's witness a reasonable opportunity to review the transcript and to consult with company's counsel concerning confidentiality of information contained in Volume 3 of the hearing transcript, New Florence requests that it be given an additional four (4) days until Friday, July 21, 2006, to file an edited copy of the transcript consistent with the Commission's Order.

3. The undersigned has discussed this request with counsel for Complainant, Staff and the Office of the Public Counsel, each of whom have indicated they do not oppose the company's request.

WHEREFORE, for good cause, New Florence requests an extension of time to comply with the Order from Monday, July 17, 2006, until Friday, July 21, 2006.
