MOTION FOR LEAVE TO AMEND APPLICATION

Tempo Telecom, LLC (“Tempo” or the “Company”), by its counsel, respectfully submits this Motion for Leave to Amend Application for Designation as an Eligible Telecommunications Carrier (“ETC”) pursuant 4 CSR 240-2.080(18).

1. On or about June 26, 2103, Tempo applied to the Missouri Public Service Commission (“Commission”) for designation as a wireless ETC in Missouri for the purpose of receiving federal universal service Lifeline support.

2. Tempo’s Application included the then-current version of Lifeline service offerings in paragraph 37.

3. Tempo requests leave to amend its Application by substituting the following updated version of its Lifeline service offerings (changes redlined):

Option 1

250 nationwide minutes including texting and Web/Internet access, with three (3) texts counting as one (1) minute of use and 1 megabyte (MB) counting as two (2) minutes of use

Option 2

150 nationwide minutes including texting and Web/Internet access, with three (3) texts counting as one (1) minute of use and 1 megabyte (MB) counting as two (2) minutes of use, with the ability to rollover unused minutes to the next month

Either option also will provide the customer with:

- Wireless handset (there are several handset options) - at least one free choice and the possibility of additional choices¹
- Voicemail
- National texting, with three (3) texts counting as one (1) minute
- 911 and E911 access as available
- Custom calling features such as call waiting, call forwarding, and caller ID
- Option for international calling with per-minute pricing based on the country to be called, which will be provided to the consumer when opting for this capability

¹ Tempo is still considering which handsets will be offered, but all handsets will be compliant with all applicable Commission requirements. Handsets will be offered for free in conjunction with the prepaid wireless Lifeline product. Based upon market availability and handset prices, the consumer may have a choice of handsets. Tempo is continuing to evaluate the possibility of offering premium handsets at an additional cost, but a free handset will always be offered to every prepaid wireless Lifeline subscriber.

Field Code Changed

- Web/Internet usage, with 1 megabyte (MB) counting as two (2) minutes of use (Web/Internet access dependent on handset)

- Option to add other wireless data plans for an additional cost (wireless data plans also dependent on handset)

- Option to purchase additional minutes (which can also be used for texting and Web/Internet access as described above) anytime during the month that are available for 30 days from purchase (and will carry over into the next month) at the following rates:

<u>Additional Minutes</u>	<u>Price</u>
<u>60</u>	<u>\$5.95</u>
<u>100</u>	<u>\$9.95</u>
<u>200</u>	<u>\$14.95</u>

- ~~Option to purchase additional minutes anytime during the month that are available for 60 days from purchase at the following rates:~~

<u>Additional Minutes</u>	<u>Price</u>
<u>200</u>	<u>13.95</u>
<u>250</u>	<u>16.95</u>
<u>300</u>	<u>19.95</u>
<u>400</u>	<u>25.95</u>
<u>900</u>	<u>49.95</u>

WHEREFORE, Tempo hereby requests the Commission to grant it leave to amend its Application.
