AMERENUE’S MOTION TO FILE SUPPLEMENTAL DIRECT TESTIMONY

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE or Company), pursuant to 4 CSR 240-2.130 and requests leave to file the Supplemental Direct Testimony of Jeff L. Dodd, which is submitted concurrently herewith, and as reasons in support thereof, states as follows:

1. On November 25, 2009, the Company filed a tariff sheet and all supporting documentation, including testimony, required to adjust the rates paid by its customers pursuant to its fuel adjustment clause, Rider FAC, as prescribed by 4 CSR 240-20.091(4).
2. Jeff L. Dodd, the Company’s Manager, Wholesale Power and Fuel Accounting, filed direct testimony on that date.
3. The Commission’s Staff discovered a typographical error in a table appearing at page 4 of Mr. Dodd’s November 25, 2009 direct testimony, and advised the Company of the error. The error involved incorrectly showing FPA_c rates by voltage class as negative numbers, instead of showing them correctly as positive numbers.
4. The remainder of the Company’s November 25, 2009 filings, including all workpapers and documentation required by 4 CSR 240-20.091(4) and the tariff sheet

(Mo. PSC Schedule No. 5, 2nd Revised, Sheet No. 98.7) properly reflected the FPA_c rates as positive numbers.

5. Mr. Dodd's Supplemental Direct Testimony, submitted concurrently herewith, simply replaces the table containing the incorrect figures with a table containing corrected figures.

WHEREFORE, for the foregoing reasons, AmerenUE hereby requests leave to file the Supplemental Direct Testimony of Jeff L. Dodd submitted concurrently herewith.
