NOTICE OF PROPOSED TARIFF LANGUAGE

COMES NOW the Office of the Public Counsel ("OPC") and for its *Notice of Proposed Tariff Language*, states as follows:

1. A Partial Stipulation and Agreement entered into between the Commission Staff ("Staff"), Spire Missouri Inc. ("Spire"), the OPC, Midwest Energy Consumers Group, Missouri Industrial Energy Consumers, Consumers Council of Missouri, Missouri School Board Association, and Vincinty Energy Kansas City Inc. was filed in the above styled case on July 30, 2021.

2. Paragraph 32 of that agreement read as follows:

The Signatories agree that the Company's currently effective facilities extension tariff sheet will be revised to incorporate a marginal revenue calculation to determine a customer's extension allowance. The Signatories will work together to draft and file with the Commission a set of mutually agreeable tariffs sheets by August 17, 2021. If the parties are unable to agree on tariff language, any Signatory may file its own proposed tariff sheet implementing this provision on August 17, in which event the parties request the issue to be taken up at the August 23, 2021 true-up evidentiary hearing.

3. It is the OPC's understanding that Spire and Staff have since met to discuss and draft a new tariff sheet pursuant to this provision. However, the OPC was not privy to these discussions. Consequently, the OPC has not been presented with a mutually agreeable tariff sheet to be filed before the Commission.

4. Pursuant to the terms of the agreement, the OPC now files its own tariff sheet implanting this provision, which is included as an attachment to this pleading, and requests that the Commission take up this issue at the August 23, 2021, true-up evidentiary hearing.

WHEREFORE, the Office of the Public Counsel respectfully requests the Commission accept this *Notice of Proposed Tariff Language* and grant such relief as requested herein and any other relief that is just and reasonable under the circumstances.
