

ORDER GRANTING MOTION TO AMEND PROCEDURAL SCHEDULE

On February 9, 2000, the Staff of the Missouri Public Service Commission (Staff), Laclede Gas Company (Laclede) and the Office of the Public Counsel (Public Counsel), filed a joint motion to amend the procedural schedule. The motion notes that on January 3, 2000, the parties filed a unanimous partial stipulation and agreement, and that the parties have made substantial progress toward agreement and are in the process of preparing a unanimous stipulation and agreement for Commission approval. The parties indicate that they expect the stipulation and agreement to resolve all of the matters at issue.

The motion also states that in the event that it is not possible to file a unanimous stipulation and agreement, the parties suggest the following alternative dates for the procedural schedule, noting that the date for hearing would remain the same as that set in the Commission's February 1, 2000, Order Granting Motion to Suspend Procedural Schedule:

Rebuttal testimony by Laclede	-	February 18, 2000
Final list of issues	-	February 23, 2000
Surrebuttal testimony by Staff	-	March 1, 2000
Parties' positions on the issues	-	March 2, 2000
Hearing	-	March 14-15, 2000

The Commission has reviewed the motion and finds it reasonable. The Commission will amend the procedural schedule as requested by the parties.

IT IS THEREFORE ORDERED:

1. That the motion to amend the procedural schedule filed by the parties on February 9, 2000 is granted.

2. That the remaining procedural dates are amended as follows:

Rebuttal testimony by Laclede	-	February 18, 2000 3:00 p.m.
Final list of issues	-	February 23, 2000 3:00 p.m.
Surrebuttal testimony by Staff	-	March 1, 2000 3:00 p.m.
Parties' positions on the issues	-	March 2, 2000 3:00 p.m.
Hearing	-	March 14-15, 2000 9:00 a.m.

3. That this order shall become effective on February 18, 2000.
