COMES NOW Laclede Gas Company ("Laclede") and for its Motion to Schedule Public Hearings in the above-captioned proceeding, states as follows:

1. On February 9, 1999, the Commission issued its Suspension Order and Notice in the above-captioned case. In its Order, the Commission directed Laclede to notify its customers of the hearings in this proceeding through a notice on or accompanying its customers' bills or through a separate notice to customers.

2. In its past rate proceedings, Laclede has utilized customer bills for purposes of providing such notice since such an approach is substantially less expensive than sending separate notices. As part of the notice, Laclede has also provided information advising its customers of the time, date and location of any public hearings which may have been scheduled by the Commission to permit public testimony on its proposed rate increase.

3. Because no Commission determination has yet been made, however, as to whether and when public hearings will be scheduled in this case, Laclede has not been able to begin the process of preparing such notices. If such a determination is not made by the second week in May, Laclede's ability to use this previously acceptable, less expensive approach for providing notice will be compromised. Under normal circumstances, it takes approximately 30 days to order, print and receive the bill stock containing such a notice, and another 30 days to complete the billing cycle. Pursuant to the Suspension Order in this case, Laclede is also under an obligation to complete the entire notice process at least ten days prior to the date of the hearings. In view of these constraints, it is critical that a determination be made on or before May 14, 1999 if public hearings are to be held in late July or early August -- dates which are compatible with the procedural schedule recently established in this proceeding.
