**MOTION TO RESCHEDULE PREHEARING CONFERENCE  
AND DATE FOR FILING PROCEDURAL SCHEDULE**

Comes now Oregon Farmers Mutual Telephone Company (Company) and for its Motion to Reschedule Prehearing Conference and Date for Filing Procedural Schedule, states to the Missouri Public Service Commission (Commission) as follows:

1. On December 20, 2000, the Commission issued its Order Granting Reconsideration, Suspending Tariff, Directing Notice, Directing Filing, Scheduling Prehearing Conference, and Establishing Protective Order in the above-referenced matter. In that Order, the Commission, among other things, established a Prehearing Conference for January 12, 2000, and directed the parties to file a proposed Procedural Schedule no later than January 23, 2001.
2. Counsel for Company has scheduled a meeting with clients out of town on January 12, 2000. That meeting was established prior to December 20, 2000, and, unfortunately, it involves a number of people and cannot be easily rescheduled. Counsel therefore requests that the prehearing conference in this matter be rescheduled to January 16, 2001, and that the date for filing a procedural schedule be extended one week to January 30, 2001.
3. Counsel for Company has discussed this proposed rescheduling with representatives of the Commission Staff and the Office of the Public Counsel and they have indicated no objection to this request. Accordingly, the Company requests that the Commission reschedule the Prehearing Conference to January 16, 2001, and the date for filing of a Procedural

Schedule to January 30, 2001.

WHEREFORE, in light of the foregoing, the Company respectfully requests the Commission issue its Order rescheduling the prehearing conference and date for filing of procedural schedule as requested herein and for such other Orders as are reasonable in the circumstances.


