**ORDER RESCHEDULING PREHEARING CONFERENCE**

On December 20, 2000, the Commission issued an order that, *inter alia*, set a date for a prehearing conference. On January 4, 2001, Oregon Farmers Mutual Telephone Company (the company) filed a pleading requesting that the Commission reschedule the prehearing conference to January 16, 2000, at 1:30 P.M. The company states that the currently scheduled date creates a conflict with a previously scheduled commitment. The company also requests that the due date for a proposed procedural schedule be January 30, 2001. The company states that the Staff of the Commission and the Office of the Public Counsel do not object to the proposed changes. The Commission will reschedule the prehearing conference and the due date for a proposed procedural schedule as requested.

**IT IS THEREFORE ORDERED:**



The prehearing conference will be held in suite 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri.
